Notice is hereby given to the taxpayers of BURNS HARBOR CIVIL TOWN, Porter County, Indiana that the proper officers of BURNS HARBOR CIVIL TOWN at 7:00 PM on Wednesday, September 14, 2011 at 1240 North Boo Road will conduct a public hearing on the year 2012 budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of the political subdivision within seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate, or tax levy that taxpayers object to. If a petition is filed, the political subdivision shall adopt with its budget a finding concerning the objections filed and testimony presented. Following the aforementioned hearing, said unit will meet at 7:00 PM on Wednesday, October 12, 2011 at 1240 North Boo Road to adopt the following budget:
