ORDINANCE 286-2018 AN ORDINANCE OF THE BURNS HARBOR

TOWN COUNCIL RE-ESTABLISHING A FINANCIAL MANAGEMENT POLICY FOR AMBULANCE AND TRANSPORT USER FEES IN BURNS HARBOR, INDIANA

WHEREAS, in February 2010, the Burns Harbor Town Council passed Ordinance 236-2010 Establishing a Financial Management Policy for

Harbor, Indiana; WHEREAS, a review of the Burns Harbor Town Code reveals that Ordinance 236-2010 was not

placed in any specific section within the WHEREAS, the Town Council seeks to re-es-

tablish these fees in amounts that adequately

cover the costs associated with providing these vital public services;

NOW THEREFORE, be it and it is hereby ordained by the Burns Harbor Town Council that Chapter 13 of the Town Code of the Town of Burns Harbor shall be amended as follows: Article IV

Ambulance and Transport User Fees Section 13-4-1 The Town of Burns Harbor establishes a Basic Life Support (BLS) user fee of \$600 for each transportation of any individual. Any treatment which is deemed "basic" by medical director protocols shall be classified as BLS. Section 13-4-2 The Town of Burns Harbor establishes an Advanced Life Support (ALS 1) user fee of \$1,000 for each transportation of any individual. Any

treatment involving the providing of intravenous fluid and/or the use of a heart monitor shall be classified as ALS 1. Section 13-4-3 The Town of Burns Harbor establishes an Advanced Life Support (ALS 2) user fee of \$1,200 for each transportation of any individual. Any treatment involving advanced drugs, traumatic injury and/or a cardiac medical event shall be

classified as ALS 2. Section 13-4-4 In addition to the user fees established in the sections above, the Town of Burns Harbor establishes a mileage charge of \$14.00 per mile for each transportation of any individual.

Section 13-4-5 The Town of Burns Harbor shall implement and/or revise a written financial management policy governing the billing and collection of ambulance and transport service user fees, effective from and after the passage of this ordinance. Said policy shall include provisions for hardship cases and write-offs. The policy shall be reviewed and may be revised by the Burns Harbor Town Council and shall be subject to and in compliance with all rules, regulations and

limitations of federal and state law. Section 13-4-6 All prior ordinances of the Town of Burns Har-bor regarding ambulance and transport user fees, including Ordinance 236-2010, are repealed and replaced by this ordinance This Ordinance shall be in full force and effect

from and after its passage, approval, recording and publication as provided by law. ALL OF WHICH HAVING BEEN PASSED AND ADOPTED by the Town Council of the Town of Burns Harbor, Indiana this 10th day of October,
